Any person aggrieved by the Minerals Core Strategy and/or the Waste Core Strategy may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004, on the grounds that the document is not within the appropriate power or that a procedural requirement has not been complied with. Any applications must be made promptly and in any event no later than 6 weeks after the date the DPD was adopted.

Copies of the Minerals and Waste Core Strategies and associated documentation (including the Inspectors Reports and Sustainability Appraisal Adoption Statement) are available for public inspection, free of charge at the following Wiltshire Council offices - Trowbridge (County Hall and Bradley Road), Chippenham, Devizes and Salisbury; and Swindon Borough Council offices at Premier House and Wat Tyler House, Swindon.
